	<p>Education & Skills: Pillars for making India the Skill Capital of the World The NEP 2020 has brought vocational and formal education closer than ever. Schools have started integrating hands-on skills along with the regular curriculum. The learners have started to understand the ever-increasing need for starting the vocational skills journey young. 	<p>Industry Driven High Quality Skilling: Road map for Engaging Industry with Education & Skills</p> <p>The Hon'ble Prime Minister has highlighted that "Skilling, re-skilling and up-skilling are the mantras for the future workforce" and "India has the potential to become one of the largest providers of skilled workforce in the world".</p> <p>To bring speed, scale and the education and skilling initiatives of our country, the role and involvement of Industry is critical. To develop a learning ecosystem that is continuous and creates professionals of the future, it is vital that the industry is actively engaged with the education ecosystem. This relationship between Industry and Academia needs to be a mutually beneficial and enriching one.</p> <p>The sunrise sectors (semiconductors, electric vehicles, biofuels, AI/ML to name a few) are attracting investments in India, we would be needing skilled manpower to be deployed in this area and hence the industry needs to interact with the learning organisations to save on time and efforts in having ready to deploy skilled manpower. The session will attempt to answer the following questions:</p> <ul style="list-style-type: none"> • How can academia and government create value that attracts the industry? Can work based learning models create value for both learners & Industry? • Understanding the needs of the industry and enabling them to engage meaningfully with Academic Institutions (Schools, HE and Vocational Institutes). • Discussing the possibilities of a national framework to foster closer ties between sectors; and promoting partnerships in professional education between private companies and educational institutions.

	<p>Green Skills and Green Jobs</p> <p>As the world today strives to transition to low carbon economic models, our education & skill training systems must support the sustainable transition toward green economies through lifelong learning approaches. Green skilling is recognized as important to align the capacities of individuals with systems change towards sustainability.</p> <p>“An additional 8.4 million jobs could be created for young people aged 15-29 by 2030 as a result of the green transition.” ILO 2022 report.</p> <p>As the demand for sustainable solutions grows, TVET systems must find efficient ways to determine the new green qualifications and competencies that are needed, to adopt approaches to embed them into curricula, and to put these competencies into practice. These include conducting a specific mapping of professions in sectors relevant to the green economy, defining and constructing relevant course contents for schools, vocational training institutes, higher education institutions and professionals.</p> <p>The session will focus on:</p> <ul style="list-style-type: none"> • Importance of developing the skills needed for inclusive and sustainable economies. • Identify skills for the transition to digital and green economies. • How can we support TVET institutions in building skills that are green and future oriented.

	<p>Empowering TVET Leadership & Practitioners: <u>Without capacity, there is no development.</u></p> <p>With the aim to work towards providing expanded access to high-quality Technical and Vocational Education and Training (TVET) opportunities, including expanded work-based learning, digital learning environments and promotion of green transitions, which effectively respond to the needs of the labour market and the society. The session aims to focus on methods and strategies for building the capacity of TVET leaders and professionals of our country. The much-needed support they need to become successful and effective agents of change in their institutions and beyond. The potential success of these change processes largely rests with the TVET leaders responsible for converting policy into practice.</p> <p>The session will focus on:</p> <ul style="list-style-type: none"> • How to address the knowledge gap on system-level change by raising awareness and developing capacities that will empower TVET professionals to support the green/Industry 4.0/Global Skills transitions. • How do we support TVET leaders and practitioners in better understanding of the market demands, business models, economic structures? • How do we ensure that they are able to co-construct systemic and social dialogues to foster entrepreneurial capacities and address the changing economic, social and developmental challenges.

	<p>Harmonisation of Skilling Initiatives of Various Ministries in India</p> <p>The absence of a single central nodal agency for formulation and release of skilling schemes has over the years created overlaps between ministries and confusion amongst the beneficiaries. Absence of a single point data base for the entire skilling ecosystem has been another challenge that has hampered the effectiveness and outcome of the skilling initiatives of the Indian Government. Today, multiple portals for multiple schemes like DDUGKY of the MoRD ; NULM of the MoHUPA ; Samarth Scheme of the Ministry of Textile ; PM Daksh of the Ministry of Social Justice and Empowerment ; Seekho Kamao from MoMA and many more exist.</p> <p>Many aspiring to be skilled get confused by so many schemes at different places. Hence, we all recognise that simplification and availability of all schemes at one place is important. The ecosystem is expected to work more efficiently if MSDE becomes the nodal agency for the formulation, and release of all Schemes related to Skill Development.</p> <p>The session will deliberate on:</p> <ul style="list-style-type: none"> • Importance and relevance of such multiple initiatives in current times. • Need for comprehensive guidelines for all Skill Development Schemes on one platform. • Role of other stakeholders, policies or regulatory compliances to create harmony between these.

	<p>VIRASAT - The Heritage' Vocal for Local: Go Global'</p> <p>Clusters play a major role in employment in India, there are approx. 3,500 clusters of basketry, weaving, printing, embroidery, bamboo and cane, earthenware, paintings, horn and bone, leather, metalware, etc. with estimated employment of 13 million people according to the NCAER. But these clusters have their own story of how they flourished once and then declined and how they are ready again to leave the mark with their unique handcrafted products.</p> <p>The traditional crafts industry is projected to become the largest non-farm rural workforce in India – with access to modern marketing techniques. The session will focus on:</p> <ul style="list-style-type: none"> • How do we support Indian craftsmen and artisans of India in making this sector as one of the largest non-farm rural sector? • How we bring forward and backward linkages closer to these local entrepreneurs? • How do we bring all stakeholders together so that independent efforts like PM Vishwakarma Yojana, SFURTI of the MSME and CTS of the MSDE are converged for the better of these artisans.
